Os. first and second rend above, the Covernment hereby agree for adoption of e-procurement in all the Urban Local Bodies, Public Health Engineering Department, APUSP., HMWS & SB and Urban Development Authorities, in respect of works / materials costing above Rs. 1.00 Lakh taken up with the Government funds (including HUDCO / Municipal Contributions) subject to following conditions;

- All the existing codal rules, G. Os, executive instructions applicable to the processing of conventional tenders are applicable to the bids to be procured through e-procurement.
- ii) In respect of the works which are included in e-procurement, tenders will not be received in the conventional method.
- The above orders shall come into force with immediate effect.
